3. **Order:** You order the licenses with reservation of a SAP maintenance offer for the respective licenses (in the event that maintenance is necessary). Not until the maintenance of the licenses by SAP is guaranteed do you receive the invoice for the purchase of license.
4. **Delivery:** Contractual documents - pre-owned software by SAP: As soon as the payment is made, you receive the following documents with our folder "Contractual Documents Pre-Owned Software SAP":

 - b. general terms and conditions of SAP of the purchase contract
 - c. last invoice of maintenance
 - d. confirmation of deletion
 - e. transfer confirmation / purchase contract of the software from supplier to susensoftware
 - f. letter of SAP informing about the change of licensee
